 - O Problems at PS #2: Ruben found, on one of the week's routine checks of the station, that the electricity was out. PG&E was working in the area and Ruben spoke with them. Both PG&E and Superior Alarm failed to notify or alert the District office. Ruben completed a test of the system and the 12v backup batter was dead, which Superior Alarm also failed to notify the District office. SA Tech will be out to replace backup batteries at both Pump Stations. Should be checked at least once a year. The Board would like the District office to draft a letter to Superior Alarm stating the issues.
