RESOLUTION NO. 1094

A RESOLUTION OVERRULING PROTESTS AND CONFIRMING REPORT ON DELINQUENT SEWER SERVICE CHARGES AND SEWER SERVICE CHARGES FOR THE FISCAL YEAR 2020-2021

SALSIPUEDES SANITARY DISTRICT

RESOLVED, by the Sanitary Board of the Salsipuedes Sanitary District, Santa Cruz County, California, that

WHEREAS, this Board did, on June 17, 2020 adopt its Ordinance No. 103, An Ordinance Amending Ordinance No. 57, entitled "An Ordinance Establishing Rates and charges for Sanitary Sewer Service and Providing Procedures for Collection and Penalties for Its Enforcement"; and (2) Providing for the Collection of Delinquent Sewer Service Charges and Sewer Service Charges for Fiscal Year 2020-2021; and directed the preparation and filing of a written report containing a description of each parcel of real property receiving services and facilities from the District and the amount of the delinquent sewer service charges and the amount of the sewer service charges for each parcel for said fiscal year; and

WHEREAS, said written report was prepared and filed with the Secretary of said District on the $17^{\rm th}$ day of June 2020; and

WHEREAS, in said Ordinance No. 103 this Board of Directors appointed the time and place of hearing protest on said report and directed notice;

WHEREAS, notice was given of the time herein stated in the manner provided by law as appears by the Proof of Publication on file in the office of the Secretary of said District;

WHEREAS, said matter came on regularly for hearing at the time fixed; and

WHEREAS, all written protests and other written communications were publicly read at said meeting and all persons desiring to be heard were fully heard;

NOW, THEREFORE, IT IS DETERMINED and ORDERED as follows:

- 1. That objections to and protests against said report were not made by the owners of a majority of the separate parcels of property described in the report against which charges for the services and facilities provided by the District were fixed.
- 2. That all objections to and protests against said report have been heard by this Board and that said objections and protests by, and each of them is, hereby overruled.
- 3. That said report, be and it is hereby adopted in full as revised, changed and modified on the face thereof, and that said charges shall be collected on the tax roll of the County of Santa Cruz, in the manner provided by law.
- 4. That the Secretary of this District be, and is hereby, directed to file with the County Auditor of Santa Cruz County on or before the 12th day of August, 2020, a copy of said report, upon which shall be endorsed over her signature a statement that the report has been finally adopted by the Sanitary Board of the Salsipuedes Sanitary District, together with a certified copy of this Resolution.
- 5. The County Auditor of Santa Cruz County shall, upon receipt of said report, enter the amount of the charges against the respective lots or parcels as they appear on the assessment roll for the fiscal year 2020-2021.
