Manager's Report

- A. SSD has set up a schedule with GreenLine to flush different areas of District
- B. SSD has set up a schedule with Superior Alarm to test the alarms on Pump Stations biweekly
- C. Follow-up classes for the Directors will be scheduled as a Special Meeting
- D. Manager has signed the Office Lease for 2 more years at the same amount.
- E. Agendized this item: as of 4/16/21, there have been 425 visits for April on website

Directors' Comments

Director Cisneros expressed appreciation to Delia Brambila, Office Manager, for inviting him to be present and view some of the District's projects this last month.

Old Business

- A. Pump Station Updates as of 4/16/21
 - <u>Pump Station #1 (Levee)</u> Tom's Septic, (Keith-pump tech) entered the wet well to correct the pump motor problem. He found and had to pry out, a guide object wedged at the bottom of the wet well, from the previous old pump that was pulled a while ago. PV Electric came out to fix the electrical issues. Impeller was also checked. Pump motor is now pumping.
 - Ruben's notes of the routine checks he completes at Pump Stations was attached for the Board members to review.
 - <u>Pump Station #2 (Condit)</u> Last alert was for "low battery" from Superior Alarm. A new backup communications battery was installed in both Pump Stations.

 - o 20-21 Sewer Service Charges was \$415,304.
 - o Capital Improvement selected was \$472, 254. Designated Funds is: \$723,071.

It was M.S.C. (Cisneros/Roberts) approving to <u>not</u> increase the Sewer Service Charges for the Residential homes in the District. The Commercial charges could be lower or higher, depending on the calculations of the meter readings.
