

**NOTICE OF PUBLIC HEARING
NOTICE OF RATE INCREASE
SALSIPUEDES SANITARY DISTRICT**

Dear Property Owner

NOTICE IS HEREBY GIVEN that the Salsipuedes Sanitary District Board of Directors will hold a public hearing to consider a proposed rate increase in the District's sewer service charges schedule. The amount of the rate increase attributable to your sewer service is set forth in the table below. This new proposed rate schedule represents an adjustment of the current charges for sewer service based upon a Wastewater Revenue study performed by the Salsipuedes Sanitary District Engineer in June 2026.

The public hearing will be held on July 15, 2026. Members of the public will have an opportunity to address oral and written communications to the Board at this hearing, which will be held at the District office, located at 739 East Lake Avenue, Suite 2, Watsonville, California 95076, and will begin at 7:00 p.m.

The proposed rate increase is necessitated by the unit costs and discharge calculations in the aforementioned revenue study, which takes into consideration a number of factors, including: increased costs, of compliance with changing regulatory requirements, operating expenses for maintenance due to the excessive grease in the sewer main, replacement and repair projects necessitated due to the aging system. For 2026-2027 the District must increase its rates because of the aforementioned factors. The rate increase was calculated to provide no more and no less than the necessary revenue the District anticipates will be needed to defray these expenses of operating, maintaining, repairing and eventually replacing the infrastructure that provides our community with a safe and reliable sanitary sewer collection system. The District's draft 2026-2027 Fiscal Year budget describes the anticipated revenues and expenses in further detail. Copies are available at the District office.
